SUBJECT: INTERVIEWS FOR THE DESIGN REVIEW BOARD**Report in Brief**

The interviews to fill two design professional openings on the Design Review Board are scheduled to begin at 5:30 p.m. on Monday, February 23, 2015.

Background

The City Council announced the opening of this recruitment on November 19, 2014 for two design professionals and set Friday, January 9, 2015 as the deadline for receipt of applications.

A total of eleven applications were received for the two positions, including the two incumbents Peter Harmon and Jack Moore. Applications were also received from Dominic Aliano, Matthew Hohenstreet, Daniel Jameyson (whom subsequently withdrew), Terry Kremin, Jason Laub, Mary Elizabeth Martinez, Rosanne Nieto, Anthony Re and Bradley Stage.

There are currently two openings on the Design Review Board. Two openings representing the expiring terms of Design Professionals Peter Harmon and Jack Moore, will be for a four-year term ending February 28, 2019. The terms of remaining members Kirk Shelby and Ross Wells expire on February 28, 2017.

The Design Review Board meets on the second and fourth Thursday of each month in the Permit Center Conference Room to review the design of each improvement for which typically a land use approval is required, and any matter referred to the Board by the Planning Commission or Zoning Administrator.

The appointment of applicants to the Design Review Board is scheduled for the Council Meeting of Tuesday, March 24, 2015.
