

Directions To Venue

FROM SAN FRANCISCO OR THE EAST BAY:

- * FROM THE BAY BRIDGE TAKE HIGHWAY 580 EAST TO HIGHWAY 24.
- * FOLLOW HIGHWAY 24 TOWARD WALNUT CREEK TAKE HIGHWAY 680 NORTH.
- * AT THE FIRST EXIT TAKE THE YGNACIO VALLEY ROAD EXIT AND TURN RIGHT.
- * FOLLOW YGNACIO VALLEY ROAD FOR 8 1/2 MILES.
- * THE PAVILION WILL BE ON THE RIGHT.

FROM SACRAMENTO:

- * TAKE HIGHWAY 80 WEST TO HIGHWAY 680.
- * PROCEED SOUTH ON HIGHWAY 680 ACROSS THE MARTINEZ BRIDGE.
- * TAKE THE HIGHWAY 4 / PITTSBURG EXIT.
- * PROCEED EAST ON HIGHWAY 4 TO RAILROAD AVENUE EXIT IN PITTSBURG.
- * TURN RIGHT ON RAILROAD AVENUE.
- * THIS BECOMES KIRKER PASS ROAD AS YOU LEAVE PITTSBURG.
- * FOLLOW KIRKER PASS ROAD FOR APPROXIMATELY 3 MILES.
- * THE PAVILION WILL BE ON YOUR LEFT.

FROM MARIN AND THE NORTH BAY:

- * CROSS THE RICHMOND BRIDGE.
- * TAKE THE FIRST EXIT AFTER THE BRIDGE, CASTRO STREET EXIT.
- * FOLLOW THE SIGNS TO THE RICHMOND PARKWAY.
- * TAKE THE RICHMOND PARKWAY TO HIGHWAY 80 AND GET ON HIGHWAY 80 EAST.
- * TAKE THE HIGHWAY 4 / MARTINEZ EXIT.
- * PROCEED EAST APPROXIMATELY 23 MILES.
- * TAKE THE RAILROAD AVENUE EXIT PITTSBURG.
- * TURN RIGHT ON RAILROAD AVENUE.

CONCORD PAVILION

- * THIS BECOMES KIRKER PASS ROAD AS YOU LEAVE PITTSBURG.
- * FOLLOW THIS FOR APPROXIMATELY 6 MILES.
- * THE PAVILION WILL BE ON YOUR LEFT.

FROM SAN JOSE AND THE SOUTH BAY:

- * TAKE HIGHWAY 680 NORTH TO THE YGNACIO VALLEY ROAD EXIT IN WALNUT CREEK.
- * TURN RIGHT ON TO YGNACIO VALLEY ROAD AND GO 8 1/2 MILES.
- * THE PAVILION WILL BE ON THE RIGHT.

FROM THE STOCKTON AREA:

- * TAKE HIGHWAY 4 TO THE RAILROAD AVENUE EXIT IN PITTSBURG.
- * TURN LEFT ON CALIFORNIA AVENUE.
- * TURN LEFT ON RAILROAD AVENUE.
- * THIS BECOMES KIRKER PASS ROAD AS YOU LEAVE PITTSBURG.
- * FOLLOW THIS FOR APPROXIMATELY 3 MILES.
- * THE PAVILION WILL BE ON YOUR LEFT AT THE NEXT SIGNAL.

FROM SAN MATEO AND THE LOWER PENINSULA:

- * FROM THE SAN MATEO BRIDGE, TAKE HIGHWAY 880 NORTH TO HIGHWAY 238.
- * TAKE HIGHWAY 580 EAST TO HIGHWAY 680 NORTH TO WALNUT CREEK.
- * TURN RIGHT ON TO YGNACIO VALLEY ROAD AND GO 8 1/2 MILES.
- * THE PAVILION WILL BE ON THE RIGHT.
