George Fulmore, Concord, inquired if a security component was involved in solving the start of the Renaissance II Fire, and spoke of possible issues for candidates running for office in District 3.

Teresa Saunders, Concord Blue Devils, announced an event scheduled for June 2 at Dave Brubeck Park, 6-8 p.m.

Margaret Hanlon-Gradie, Contra Costa AFL-CIO, thanked the staff for pulling Agenda Item No. 9.c from consideration from the agenda.

Debra Bernstein, Raise the Roof Coalition, recapped the May Day event held by the Raise the Roof Coalition and submitted postcards in support of tenant protections and stabilized rental costs.

Ken Scoles, Bay Point, spoke of the need and desire for a Veterans Village at the Concord Naval Weapons Station.

Anonymous spoke of the poor presentation by Lennar at the last CAC meeting and the January meeting with BART regarding the buffer.

9. CITY COUNCIL CONSENT CALENDAR

The public is entitled to address the City Council on items appearing on the Consent Calendar before or during the City Council's consideration of the Consent Calendar. (Measure Q and General Fund) Recommended by the Director of Public Works.

CEQA: Categorically exempt pursuant to CEQA Guidelines Sections 15301 – Existing Facilities, 15302 – Replacement or Reconstruction.

ACTION: Bid protest from Alex Li of Construction West Services, Inc. rejected; contract awarded to Alex Kushner, General Contractor, in the amount of \$92,400 for the Council Chamber restrooms remodel; City Manager authorized to execute the contract in a form acceptable to the City Attorney.

c. **Considering** – award of three-year contract for custodial maintenance services in the amount of \$376,000 per year to Enviro Clean Maintenance of Hayward, CA, with the option to extend the contract for two (2) additional one (1) year periods; and authorizing the City Manager to execute the contract in a form acceptable to the City Attorney. (Building Maintenance Fund) Recommended by the Director of Public Works.

This item was pulled from consideration by staff to return at a later date.

d. **Considering** – adoption of Resolution No. 18-42 allowing the City of Pleasant Hill to include Sunvalley Mall and certain other City of Concord commercial

properties in the Pleasant Hill Landscaping and Lighting Assessment District No. 20. (No fiscal impact) Recommended by the Director of Public Works.
