3. **CITY COUNCIL CONSENT ITEMS:**

- a. **Approving** – the minutes from the meeting of April 7, 2015. (No Fiscal Impact) Recommended by the City Clerk.
- b. **Accepting** – the Preliminary Engineer’s Reports and ordering improvements in the Downtown Landscape Maintenance District, Pine Hollow Landscape Maintenance District, Landscaping and Lighting Maintenance District No. 3, and the Citywide Street Lighting Assessment District, and setting a Public Hearing for May 26, 2015. Resolution Nos. 15-22, 15-23, 15-24, 15-25, 15-26, 15-27, 15-28 and 15-29 for adoption. Recommended by the Director of Public Works.
- c. **Approving** – the agreement between the City of Concord and the City of Clayton to provide for dispatch, computer-aided dispatch system services, and temporary holding and detention services until June 30, 2019; and authorizing the City Manager to execute the agreement. Recommended by the Chief of Police.

- d. **Approving** – Capital Improvement Project No. 2336 (Community Electronic Bike Lockers at Concord’s Civic Center and Public Library); accepting Transportation Fund for Clean Air Regional Grant in the amount of \$10,000; appropriating project funding; and authorizing execution of the Funding Agreement. (TFCA Grant and General Funds) Recommended by the Director of Community and Economic Development.
- e. **Adopting** – Ordinance No. 15-3 entitled, “AN ORDINANCE OF THE CITY OF CONCORD AMENDING CONCORD MUNICIPAL CODE TITLE 2, ADMINISTRATION; CHAPTER 2.20 BOARDS, COMMISSIONS AND COMMITTEES.” Ordinance No. 15-3 was introduced on April 7, 2015, by reading of the title only and waiving further reading. Recommended by the City Clerk.
- f. **Authorizing and appropriating** – the acceptance of State AB 109 Funds in the amount of \$126,907 to fund the cost of a new police officer to provide coordinated support of AB 109 law enforcement activities. Resolution No. 15-30 for adoption. (AB 109 Funds) Recommended by the Chief of Police.

4. CITY COUNCIL PUBLIC HEARING:

- a. **Approving** – the Draft 2015/20 Consolidated Plan and the Draft FY 2015/16 Action Plan, including the Community Services Commission 2015/16 funding recommendations for programs/projects. Resolution No. 15-20 for adoption.

Staff Recommendation: Hear the report, take public testimony, and adopt Resolution No. 15-20 approving the Draft 2015/20 Consolidated Plan and the Draft FY 2015/16 Action Plan.

5. LOCAL REUSE AUTHORITY CONSENT ITEMS:

- a. **Approving** – amendment to the Master Services Agreement with HR&A Advisors, Inc. (HR&A) for professional services associated with the Economic Development Conveyance (EDC) application and business plan and developer selection process at the Concord Naval Weapons Station (CNWS) in an amount not to exceed \$35,000; funding will be provided from a loan to the Local Reuse Authority (LRA) from the General Fund. Total funding since 2012 is \$245,000. Recommended by the Local Reuse Authority Executive Director.

- b. **Approving** – amendment to the Master Services Agreement with Arup Inc. for professional services associated with land transfer/development planning at the Concord Naval Weapons Station (CNWS) in an amount not to exceed \$35,000. Funding will be provided by a loan to the Local Reuse Authority (LRA) from the General Fund. Total funding since 2006 is \$10.2 million. Recommended by the Local Reuse Authority Executive Director.

NOTICE

There is a 90-day limit for the filing of a challenge in the Superior Court to certain City administrative decisions and orders which require a hearing by law, the receipt of evidence, and the exercise of discretion. The 90-day limit begins on the date the decision is final (Code of Civil Procedure Section 1094.6). Further, if you challenge an action taken by the City Council in court, you may be limited, by California law, including but not limited to Government Code Section 65009, to raising only those issues you or someone else raised in the public hearing, or in written correspondence delivered to the City Council prior to or at the public hearing. The City Council may be requested to reconsider a decision if the request is made prior to the next City Council meeting, regardless of whether it is a regular or special meeting (Policy and Procedure No. 2, Section 4.24). SPEAKER'S CARD - Members of the audience who wish to address the City Council are requested to complete a Speaker's Card available at the front bench. Submit the completed card to the City Clerk before the item is called, preferably before the meeting begins.

AGENDA REPORTS - Agenda reports are available for public viewing in a binder on the front staff desk.

PUBLIC COMMENT PERIOD - This is a fifteen-minute Public Comment Period for items not on this agenda, and each speaker will be limited to approximately three minutes. State law prohibits the City Council from acting at this meeting on any matter raised during the Public Comment Period.

CONSENT CALENDAR - Adoption of the Consent Calendar may be made by one motion of the City Council, provided that any Councilmember, individual or organization may request removal of an item from the Consent Calendar for separate consideration. If a request for removal of an item from the Consent Calendar has been received, the Mayor may defer action on the particular item and place the same on the regular agenda for consideration in any order s/he deems appropriate.

PUBLIC HEARINGS - Persons who wish to speak on Public Hearings listed on the agenda will be heard when the public hearing is opened, except on public hearing items previously heard and closed to public comment. After the public has commented, the item is closed to further public comment and brought to the Council/Agency level for discussion and action. Further comment from the audience will not be received unless requested by the Council/Agency. No public hearing shall commence after 10:00 p.m. unless approved by majority vote of the City Council.

ADA NOTICE AND HEARING IMPAIRED PROVISIONS - The Council Chamber is equipped with Easy Listener Sound Amplifier units for use by the hearing impaired. The units operate in conjunction with the Chamber's sound system. You may request the Easy Listener Phonic Ear Personal Sound Amplifier from the City Clerk for personal use during Council meetings.
