**SUBJECT: APPOINTMENTS TO THE COMMISSION ON AGING AND COMMUNITY SERVICES COMMISSION****Report in Brief**

This report presents a recommendation to make three (3) appointments to Commission on Aging, each for a term ending June 30, 2019 and seven (7) appointments to the Community Service Commission, three (3) for terms ending June 30, 2017 and four (4) for terms ending June 30, 2019.

**Background**

The Commission on Aging consists of up to eleven (11) members serving four (4) year terms. The terms of incumbents Linda Bailey, Charles Rogers and Lela Elloway expired on June 30, 2015. Lela Elloway resigned prior to the opening of the recruitment process and Charles Rogers did not reapply. The recruitment for applicants to the Commission on Aging was announced on April 14, 2015, with a closing deadline of May 22, 2015. The recruitment resulted in eight (8) applicants, including one incumbent.

On April 7, 2015 the City Council approved the separation of the Community Services Commission (CSC) and the Concord Pleasant Hill Health Care District Grant Committee (CPHHCDGC) into two separate bodies with the CSC consisting of seven (7) members and the CPHHCDGC consisting of five (5) members. Due to the restructuring of these two committees, this appointment is to fill all seven members of the CSC and all five positions of the CPHHCD. The current members of the CSC were invited to apply for appointment. The recruitment for applicants to the Community Services Commission and Concord Pleasant Hill Health Care District Grant Committee was announced on April 14, 2015, with a closing deadline of May 22, 2015. The recruitment resulted in thirteen (13) applicants for CSC and seven (7) applicants for CPHHCDGC.


**Council Committee Recommendation**
