SUBJECT: APPOINTMENTS TO THE CONCORD PLEASANT HILL HEALTH CARE DISTRICT GRANT COMMITTEE

Report in Brief

The Recreation, Cultural Affairs and Community Services Council Committee met and interviewed candidates for the Concord Pleasant Hill Health Care District Grant Committee on Thursday, October 22, 2015.

Background

On April 7, 2015, the City Council approved the separation of the Community Services Commission (CSC) and the Concord Pleasant Hill Health Care District Grant Committee (CPHHCDGC) into two separate bodies.

The City Council announced the opening of this recruitment on July 14, 2015, then extended it and set Friday, September 25, 2015, as the deadline for receipt of applications.

Discussion

Interviews were held on Thursday October 22, 2015, by the Council Committee on Recreation, Cultural Affairs and Community Services in the Garden Conference Room.

The new Committee Members will join the Pleasant Hill appointed members: Jack Noyes and Barbara Sandoval. The Concord Pleasant Hill Health Care District Grant Committee is expected to begin meeting in November 2015.
