Subject: **Appointment to the City of Concord Planning Commission**

Report in Brief

Appoint an applicant to the City of Concord Planning Commission to fill an unscheduled vacancy created by the resignation of Ernesto Avila.

Recommended Action

Staff recommends that the City Council appoint, through a balloting process, one applicant to the City of Concord Planning Commission for a term ending February 28, 2017.

Background

There is one opening on the City of Concord Planning Commission for a term ending February 28, 2017. The Concord Planning Commission is composed of five members who must be Concord residents and hold no other municipal office in the City of Concord. The Planning Commission develops and maintains a long-range, comprehensive General Plan; develops specific plans as may be necessary or desirable; reviews Planned Unit Development, Planned District Development, Tentative Subdivision Maps, Use Permits and Rezoning applications; and performs such other functions as the legislative body may provide.

On March 16, 2016, Planning Commission Ernesto Avila was appointed to the Contra Costa Water District Board of Directors, leaving an unscheduled vacancy on the Planning Commission. The recruitment to fill the position was announced on April 5,

2016, and May 6, 2016 was set as the deadline for receipt of applications by the City Clerk.

Interviews were held at a regular meeting of the City Council on Tuesday, July 5, 2016 in the Garden Conference Room.
