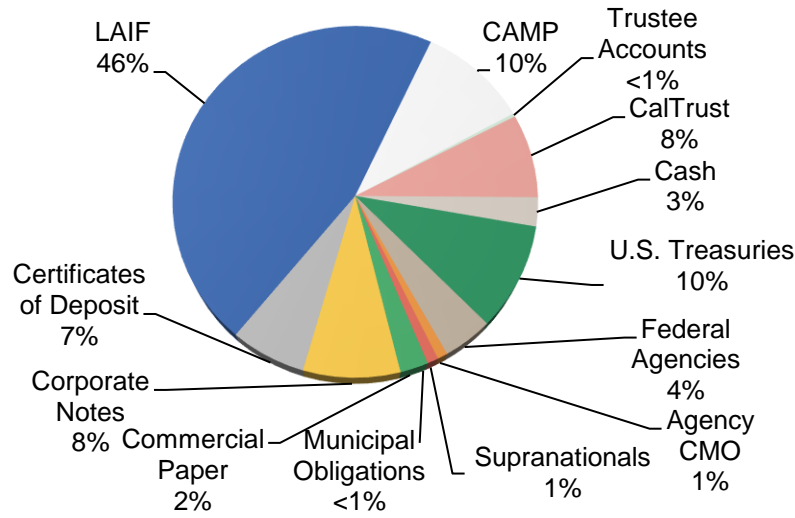

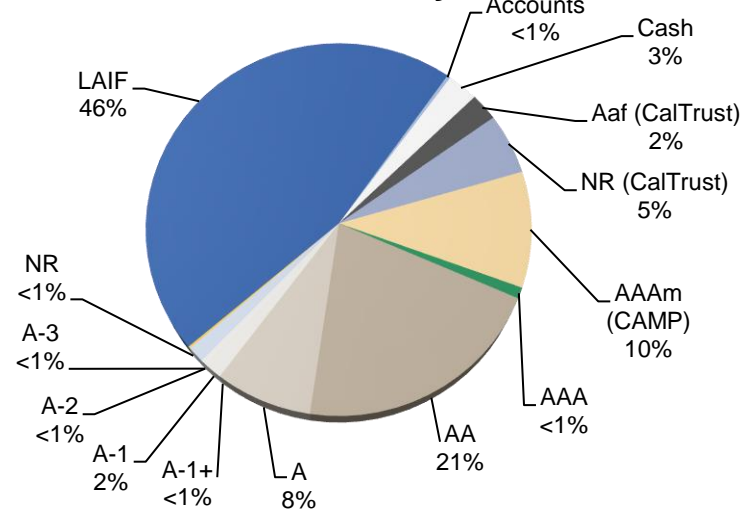

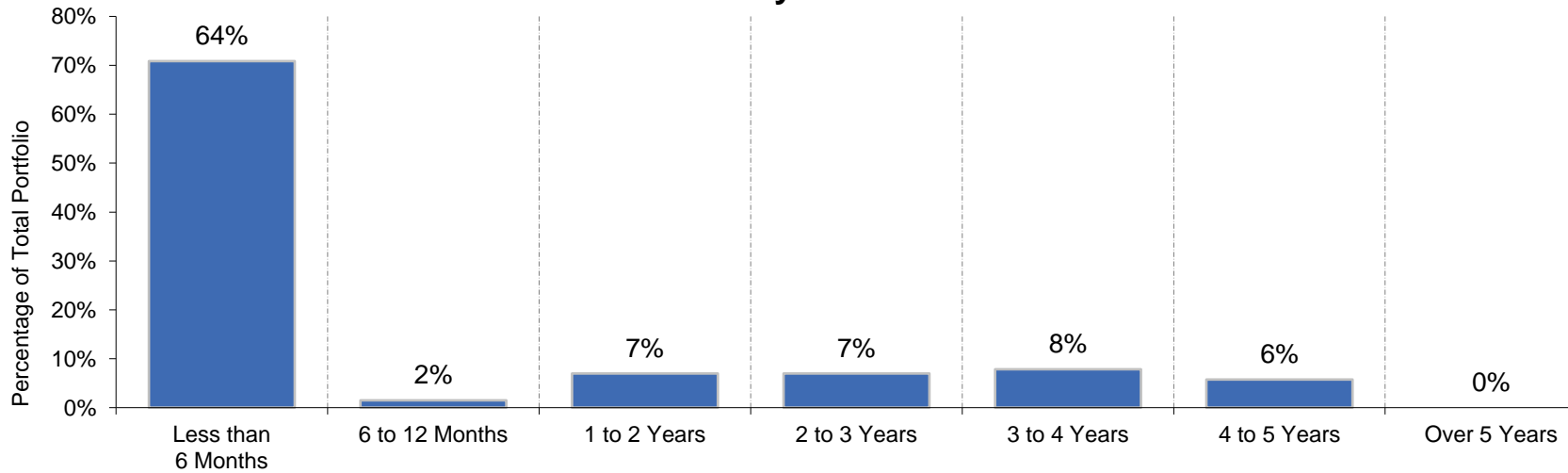
Sector Breakdown
